Sub: Complaint against (i) Prasenjit Gope @ Bikash (22 yrs) S/o Ghanashyam Gope & (ii) Mangal Gope (21 yrs) S/o Kuila Gope both are of Vill-Jugilong, PS- Nimdih, Dist-Seraikela-Kharsawan, Jharkhand to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely (i) Prasenjit Gope @ Bikash (22 yrs) S/o Ghanashyam Gope & (ii) Mangal Gope (21 yrs) S/o Kuila Gope both are of Vill-Jugilong, PS- Nimdih, Dist-Seraikela-Kharsawan, Jharkhand and seized (i) 02 (Two) white colour plastic Jaricanes containing 30 (Thirty) liters I.D liquor (Cholai) from which 500 ml ID Liquor (Cholai) both seized as sample in a plastic bottle which kept in two carrying plastic bag in the Motor-cycle bearing Reg. No- JH05D-8372 (Hero Honda Passion) under proper seizure list.

I, ASI Uttam Mandal of Barabazar PS do here by lodge this complaint against one (i) Prasenjit Gope @ Bikash (22 yrs) S/o Ghanashyam Gope & (ii) Mangal Gope (21 yrs) S/o Kuila Gope both are of Vill-Jugilong, PS- Nimdih, Dist-Seraikela-Kharsawan, Jharkhand. I beg to state that on 21.07.2024 myself along with force (i) C/730 Tapas Mandal & (ii) C/960 Golak Bihari Mahato were left for mobile duty vide Barabazar PS C.C No-3422/24 Dtd. 21.07.2024. During mobile duty at about 19:45 hrs I received an information that 02 (two) persons were Carrying and selling I.D liquor (Cholai) at Sankhari Bypass More under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the spot to work out the information.

At about 20:15 hrs myself along with force held raid at Sankhari Bypass More and apprehended one Motor-Cycle having Reg. No JH05D-8372 along with 02 (Two) bags containing ID Liquor (Cholai) from the possession of (i) Prasenjit Gope @ Bikash (22 yrs) S/o Ghanashyam Gope & (ii) Mangal Gope (21 yrs) S/o Kuila Gope both are of Vill-Jugilong, PS- Nimdih, Dist-Seraikela-Kharsawan, Jharkhand and found that they were carrying & selling ID Liquor (Cholai) at that locality. On search I found (i) 02 (Two) white colour plastic Jaricane containing 30 (Thirty) liters I.D liquor (Cholai) from which 500 ml ID Liquor (Cholai) both seized as sample in a plastic bottle which kept in two carrying plastic bag in the Motor-cycle bearing Reg. No- JH05D-8372 (Hero Honda Passion). On interrogation, both Prasenjit Gope @ Bikash & Mangal Gope confessed their guilt and stated that they selling the I.D liquor (Cholai) by their Motor-Cycle to the local people with intent to make their own profit. They also admitted that they have no license or any authorization for keeping or selling of I.D liquor (Cholai) and they disclosed their identity as noted above.

Accordingly, I seized (i) 02 (Two) white colour plastic Jaricane containing 30 (Thirty) liters I.D liquor (Cholai) from which 500 ml ID Liquor (Cholai) both seized as sample in two plastic bottles which kept in two carrying plastic bag in the Motor-cycle bearing Reg. No- JH05D-8372 (Hero Honda Passion) and (ii) One Motor-Cycle (Hero Honda Passion) bearing Reg. No- JH05D-8372 under proper seizure list duly signed by the witnesses and labeled by me. The seizure and label was done in between 20:45 hrs to 21:05 hrs.

Thereafter, I arrested the accused persons namely (i) Prascnjit Gope @ Bikash (22 yrs) S/o Ghanashyam Gope & (ii) Mangal Gope (21 yrs) S/o Kuila Gope both are of Vill-Jugilong, PS- Nimdih, Dist-Seraikela-Kharsawan, Jharkhand after preparing Memo of Arrest & after observing all other formalities regarding arrest as per B.N.S.S. and NHRC guideline. Accordingly, informed them and their relatives regarding the ground of arrest. The arrest was made on 21.07.2024 at 21:15 hrs & 21:25 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused persons namely (i) Prasenjit Gope @ Bikash (22 yrs) S/o Ghanashyam Gope & (ii) Mangal Gope (21 yrs) S/o Kuila Gope both are of Vill-Jugilong, PS- Nimdih, Dist-Seraikela-Kharsawan, Jharkhand under proper section of Law.
