Respected Sir,

With due respect I would like to draw your kind attention that on 04/06/24 at 19:50 hrs. I was endorsed by you to enquire Jhalda PS U/D Case No-18/24 dated-04/06/24. Accordingly, I started enquiry in the U/D case. In course of enquiry it was found that the U/D case was started on receipt of a written information from Dr. Nilima Mahato M.O of Jhalda BPHC citting that the deceased namely Budhu @ Budhuram Kuiry (67) S/O Lt. Sridam Kuiry of Vill-Sarjumatu, PO-Ichag, PS-Jhalda, Dist-Purulia. I with the help of my accompany C/1394 Gurudas Bouri held inquest upon the dead body of deceased Budhu @ Budhuram Kuiry (67) S/O Lt. Sridam Kuiry which was lying at Jhalda BPHC in presence of his family members as well as staff of Jhalda BPHC. During careful observation of the dead body of the deceased no such remarkable external injury was found over the body. During preliminary enquiry it was stated by the family members of the deceased that the deceased Budhu @ Budhuram Kuiry was found lying unconscious in the courtyard of their house at Vill-Sarjumatu indicating it as a case of accidentally falling on the ground and at that moment I had no option to verify the statement of the family members of the deceased regarding the cause of death of the deceased. After completion of inquest dead body was send to Deben Mahata Govt. Medical College & Hospital, Hatuara, Purulia for holding P.M to ascertain to original cause of death. On 26/06/2024 I collected the P.M report of deceased Budhu @ Budhuram Kuiry and on perusal of it was found that the Autopsy Surgeon Dr. Tapas Sinha opined the cause of death of the deceased Budhu @ Budhuram Kuiry as "death was due to the effects of head injury, as noted above, ante mortem in nature and homicidal in manner" vide PM No- 590/24 Date-05/06/24.

After getting the P.M. report I also enquired the matter in the locality and a good number of villagers who did not disclosed the identity, suspect it a case of murder but they could not have mentioned the name of any suspect in this case.

Under the such circumstances I am also on the opinion that there is a strong possibility some ones had murder him. Due to some unknown ulterior motive.

Hence, I pray that a specific case may kindly be started and arrange for its investigation.
