Out of which I seized the following.

1. PVC (aluminum) single core two wire of approx length 50 feet.

The inspection team left the premises at 01.10 P.M on 10.07.2024. The accused person has committed an offence U/S 135(1)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
