DEBENDRANATH MANDAL , resident at- CHOTO PATUB, PS:- JHALDA, Dist- PURULIA was enjoying electricity unauthorized i.e. hooking from nearest LTOH line and due to this reason he- has committed theft of electricity U/S 135 (1/a)of the electricity (Amendment act- 2007) on 10.07.2024 at 02.40 P.M.

During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCCL i.e. U/S 135(1/a) was detected.

From the above arrangement he/she uses the following electrical equipments.

- 2 Electric Fan 03 nos.
- 3 Electric Pump 01 nos
- 4 Refrigerator-01 nos
- 5 TV-01 nos.

Out of which I seized the following.

- 1 PVC (copper) single core single wire of approx length 22 feet each fitted with hooking device.

Seizure list was prepared at the site and accused person signed.

The inspection team left the premises at 03.00 P.M on 10.07.2024. The accused person has committed an offence U/S 135(I)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
