Entered the premises of SANJAY KUMAR RAY (USER), S/o-LT. DINO BANDHU RAY, resident at PURANO
JHALDA, PS- JHALDA, Dist- PURULIA having consumer Id- 242011143, Meter no (PBR23679) and inspected
his/ her premises. During the inspection theft of electricity was detected i.e. by tapping the incoming
service cable i.e. U/S 135(I)(b) was detected. The details of bypassing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 20 nos.
2. Pump-02 nos.
3. Color T.V- 02 no.
4. Electric Fan - 10 no
5. Cooler- 01 no.
6. Refrigerator- 02 nos.
7. Inverter- 02 nos.

Out of which I seized the following.

1. Single core two wire (aluminum PVC cable) length 12 ft. with bypassing arrangement.

Seizure list was prepared at the site and accused person refused to sign. The inspection team left the
premises at 02:45 P.M on 25.07.2024. The accused person has committed an offence U/S 135(I)(b) of the
electricity act-2003 subsequently electricity (Amendment) act-2007. You are requested to take cognizance
of this complaint & treat it as F.I.R. and action may be taken as per rule.
