In producing herewith 02 (two) arrested accused persons namely (1) Dhananjay Kumar (32 yrs), S/O- Lt. Lakshman Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia and (2) Pintu Mahato (21 yrs) S/O- Bhairav Mahato of Vill-Het Kahan, PS-Joypur, Dist-Purulia along with seized 03 (three) Tractors (1) One blue Colour POWERTRAC 439 PLUS tractor bearing Chassis No.- T053468950HH, Engine No.- E3527820 with trolley loaded with sand (100 CFT approx) (2) One Red Colour Mahendra B275 DI tractor bearing Regd. No- JH09AM/ 8916 with trolley loaded with sand (100 CFT approx) (3) One blue Colour POWERTRAC EURO 439 tractor bearing Chassis No.- T053495022EJ, Engine No.- E3557188 with trolley loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today i.e 05.07.24 I, SI Malay Mishra along with (1) C/2848 Prasanta Saren (2) HG/1717 Phanibhusan Mahato (3) C/1358 Sanjit Kr Patra all of Joypur P.S were performing special day mobile duty over PS area vide Joypur PS CC No-1879 Date-05/07/24. During mobile duty when we reached near to Joypur Krishak Bazar ( Purulia – Jhalda road, SH- 4A) at 13.50 hrs and found 03 (three) tractors were coming from Rakhbor more side towards Joypur. We stopped the Tractors and found that each vehicle was loaded with sand. On seeing the Police party, one of the drivers fled away from the spot but we manage to apprehend rest two drivers and all three tractors.

On integration they disclosed their identity as Dhananjay Kumar & Pintu Mahato. I asked the drivers to produce valid documents in respect of said sand but they failed to produce any valid documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admit that they are dealing with illegal sand lifting from Kangsabati riverbed (Deulghata Nadighat) and transporting the sand. The drivers also failed to produce any paper in respect of the Tractors. Hence, I seized the 03 (three) Tractors (1) One blue Colour POWERTRAC 439 PLUS tractor bearing Chassis No.- T053468950HH, Engine No.- E3527820 with trolley loaded with sand (100 CFT approx) (2) One Red Colour Mahendra B275DI tractor bearing Regd. No-JH09AM/8916 with trolley loaded with sand (100 CFT approx) (3) One blue Colour POWERTRAC EURO 439 tractor bearing Chassis No.- T053495022EJ, Engine No.- E3557188 with trolley loaded with sand (100 CFT approx) in between 13.56 hrs to 14.13 hrs under proper seizure list with videography in presence of available Police witnesses as independent witness were not available. I arrested the drivers namely (1) Dhananjay Kumar (32 yrs), S/O- Lt. Lakshman Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia and (2) Pintu Mahato (21 yrs) S/O- Bhairav Mahato of Vill-Het Kahan, PS-Joypur, Dist-Purulia, after observing all formalities & disclosed them ground of arrest. I brought them with said Tractors to Joypur P.S. As such there is every reason to believe that the **drivers and owners** of the tractors are dealing with sand illegally and transporting with ill motive without any valid documents.

Therefore, I pray before you that a specific case kindly be started against (1) Driver Dhananjay Kumar (32 yrs), S/O-Lt. Lakshman Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia and owner of the seized tractor bearing Chassis No.- T053468950HH, Engine No.- E3527820 (2) Driver Pintu Mahato (21 yrs) S/O- Bhairav Mahato of Vill-Het Kahan, PS-Joypur, Dist-Purulia and owner of the seized tractor bearing Regd. No-JH09AM/8916, and (3) Driver and owner of the seized tractor bearing Chassis No.- T053495022EJ, Engine No.- E3557188 under proper section of law.
