

Sir.

In producing herewith one arrested accused person namely Sujit Gope (25 yrs) S/o-Deben Gope of Vill-Dhabani PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizure list i.e. 29 (Twenty-nine) bottles DILKHUSH country sprit each bottle 600 ML with sealed condition and 01 bottle labeled as sample.

I SI Gourango Roy of Joypur PS do hereby lodge a typed complaint against the above noted arrested accused person to the effect that on today (28/07/2024) at about 19:05 hrs when myself along with C/-681 Notan Dey & C/-696 Sibprasad Singh Sardar were performing special mobile duty at PS area, as per my source information I reached near Dhabani village more at Pokori stall of Sujit Gope under Joypur PS and found that the above noted accused person was selling the above noted seized articles in his stall. On seeing Police persons, he concealed his presence at that stall, but on searching we could trace out him and also found the above noted seized articles from his stall. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling the said liquor to the local people at Dhabani village area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such liquor. So it is reasonable to believe that he was selling the said liquor illegally without any documents. So I seized the same under proper seizure list in between 19:42 hrs to 19:48 hrs & labeled the same, duly signed by him and other available witness after taking of 01 piece labeled as sample out of rest seized articles. During further interrogation he confessed his guilt as such I arrested him today 28/07/2024 at 19:50 hrs abiding by all the procedure laid down in BNSS and the latest guidelines of the Apex Court as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Sujit Gope (25 yrs) S/o-Deben Gope of Vill-Dhabani PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
