In producing herewith the following arrested accd. persons (i) Mahalaya @ Hablu Kumar (25 years) S/O-Helaram Kumar of Vill-Beldih, P.S- Kotshila, Dist.- Purulia (ii) Uttam @ Bhatu Rajak (22 years) S/O-Haradhan Rajak of Vill-Burda, P.S-Baghmundi, Dist.-Purulia and brought under seizure the following articles-(1) One Iron made "Hasua" with Iron Butt, Total Length approx 21", out of Butt 09" & (2) One Iron "Rod" Length approx 40" and diameter approx 3" after preparing a seizure list duly signed by the witnesses as well as accd. persons. I do hereby lodge a written complaint against the above noted accd. persons and others 05/06 persons to the effect that on 29.06.24 at 23:35 hrs ASI Prasanta Kr Pan (Duty Officer) received information from creditable source that 07/08 criminals assembled in an open place beside Begunkodar Swashan Kali Mandir with a view to commit dacoity at Begunkodar market. After getting such type of information ASI Prasanta Kr Pan noted the fact in G.D. vide Kotshila P.S GDE No. 1248 Date 29.06.24 and informed the matter to O/C, Kotshila P.S. and as per his direction I along with C/1279 Bhabataran Mahato, C/983 Radhakanta Kisku, C/2705 Sanjoy Kar, C/2555 Abhijit Mahapatra Vide CC No. 2077/24 Date 29.06.2024 proceeded towards the Begunkodar Market to work-out the said information. I along with forces reached nearby spot at 00.15 hrs (30.06.24) and on keeping safe distance stop the vehicle by the side of the road and proceeded to the Begunkodar Market on foot and when we reached near the spot and found 07/08 persons sitting and whispering each and others. We tried to apprehend them but seeing the police party they tried to flee away but on hot chase we able to apprehend the above noted 02 (two) accd. persons. On immediate search on their person recovered One Iron made "Hasua" with iron Butt, from the right hand grip of accd Mahalaya @ Hablu Kumar, and One Iron Rod recovered from Uttam @ Bhatu Rajak. On being asked they disclosed their identity as noted above and other persons who were unknown to them, but they fled away on getting the scent of police. On being asked they could not give any satisfactory reason for keeping the, "Hasua" and other weapons to assemble the place at the dead hour of night. On interrogation they also stated that they all assembled there to commit dacoity at the Begunkodar market. I seized all offending weapons from 00.45 hrs to 01.25 hrs after preparing proper seizure list duly signed by the accd. persons as well as police witness as there are no such public witnesses was available at the dead hours of night. After that I arrested all 02 (two) accd. persons as noted above from 01.35 hrs to 01.50 hrs. Issued memo of arrest and inform them regarding ground of arrest. Observed all legal formalities of arrest as per guidelines of Hon'ble Apex Court.

So I, therefore, lodged a complaint against accd. persons namely (i) Mahalaya @ Hablu Kumar (25 years) S/O-Helaram Kumar of Vill-Beldih, P.S- Kotshila, Dist.- Purulia (ii) Uttam @ Bhatu Rajak (22 years) S/O-Haradhan Rajak of Vill-Burda, P.S-Baghmundi, Dist.-Purulia and other 05/06 persons under proper section of law.
