I ASI Mrityunjoy Bhakat of Kotshila PS, Dist- Purulia producing herewith two arrested accused persons namely (1) Rabindra Singh Majhi (50 yrs) S/O-Nagendra Singh Majhi (2) Santosh Singh Majhi (19 yrs) S/O-Rabindra Singh Majhi both of Vill-Upargugui, PS-Arsha, Dist-Purulia along with seized articles i.e. (1) One white colour bag (Tholi) (2) Approx 02 (two) Ltr ID liquor in a white plastic jaricane (3) Approx 4.5 (four and half) Ltr ID Liquor in a five ltr jaricane (4) Approx 05 (five) Ltr ID liquor in a white plastic (5) One black colour Hero Super Splender bike having Reg No. JH 11AF 6356 (Total 11.5 (eleven and half) ID liquor out of it 500 ml ID liquor as sample which was collected from seized articles from Sl. No-02 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (12.07.2024) during evening mobile duty vide Kotshila PS C.C No. 2221/2024, Dated 12.07.2024 acting upon a secret source information myself along with C/1279 Bhabataran Mahato and C/806 Somnath Saha both are of Kotshila PS conducted raid at an open field near Kochahatu village at about 19:25 hrs and found that the above noted persons was coming form Kochahatu village side with a bike for selling of ID liquor (Cholai) to the others. Seeing the Police party they tried to fleed way but we managed to apprehend the above noted accused persons. On being asked they failed to produce any valid license / documents in respect of selling ID liquor. As such I seized (1) One white colour bag (Tholi) (2) Approx 02 (two) Ltr ID liquor in a white plastic jaricane (3) Approx 4.5 (four and half) Ltr ID Liquor in a five ltr jaricane (4) Approx 05 (five) Ltr ID liquor in a white plastic (5) One black colour Hero Super Splender bike having Reg No. JH 11AF 6356 (Total 11.5 (eleven and half) Ltr. ID liquor out of it 500 ml ID liquor as sample which was collected from seized articles from Sl. No-02 & kept in a bottle in their possession under proper seizure list in presence of witnesses and duly signed by them in between 20:05 hrs to 20:25 hrs and also arrested the above noted accused persons at 20:35 hrs & 20:40 hrs after informing them the ground of arrest and after observing all legal formalities. The seized articles except bike were properly sealed and labeled in presence of witnesses. I also arranged to inform their family members about their arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against (1) Rabindra Singh Majhi (50 yrs) S/O-Nagendra Singh Majhi (2) Santosh Singh Majhi (19 yrs) S/O-Rabindra Singh Majhi both of Vill-Upargugui, PS-Arsha, Dist-Purulia as per law
