Sub:- Complain for starting a specific case .

Sir,

In producing herewith the seized Tractor having registration No- WB 81/0391, Engine No- RENW02976 & Chassis No- RENW02976 (Mahindra 265 DI, Red Colour) along with trolley loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, ASI Pradip Chakraborty along with C/307 Sasanka Sekhar Bai and C/05 Biswajit Mahapatra were performing anticrime evening mobile duty at PS area vide Neturia PS GDE No- 759 Dt. 18.07.24 & CC No- 2398/24 Dt. 18.07.24 at about 21:45 hrs while performing mobile duty at Sarbari More, received a credible source information that one tractor bearing registration No- WB 81/0391 loaded with illegal sand in trolley coming from Saltore village side towards Pathardiha village side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Pathardiha village side and at about 22:05 hrs reached at Pathardiha Road near Parbelia Saraswati learning new school and found that above noted tractor was coming from Saltore side and suddenly the driver stopped the tractor there and after seeing the police party, he got down from the tractor and started to run towards the village area. We chased to apprehend the driver but in spite of hot chase he managed to flee away. Then we searched the tractor and found that the vehicle (tractor) having registration No- WB 81/0391, Engine No-RENW02976 & Chassis No- RENW02976 (Mahindra 265 DI, Red Colour) loaded with sand in Trolley approx 100 Cft. I along with force waited there for some time but no one turn up at that moment & none produce any valid documents in respect of that sand.

So, there is reason to believe that the driver and registered owner of the tractor have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner knowing it to be stolen.

Accordingly, I seized the tractor having registration No- WB 81/0391, Engine No-RENW02976 & Chassis No- RENW02976 (Mahindra 265 DI, Red Colour) along with trolley loaded with sand approx 100 C.Ft. at 22:35 hrs to 22:45 hrs under proper seizure list duly signed by witnesses with videography.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of tractor having registration No- WB 81/0391, Engine No-RENW02976 & Chassis No- RENW02976 (Mahindra 265 DI, Red Colour) under proper section of law and arrange its investigation.
