Dear Sir.

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Debilal Tudu S/O-Lt. Ramsuraj Tudu, a permanent resident of Vill- Salchura, P.S. -Neturia, Dist- Purulia has committed theft of Electricity u/s 135 1(a) of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 24.07.2024 at about 01:00 PM I, Sri Dhritiman SardarS/O- Sri Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri ParthaChakraborty, DE (S&LP) Purulia Region, Sri Promod Ranjan Barman, SO of Purulia Region S & LP Unit Sri DayamayMahato Sr. TSH of Purulia Region S & LP Unit, Sri Souvik Mudi, J.E. (Gr-II) attached to Saltore CCC and others had been to the village Salchura for routine inspection purpose. During inspection it was detected that Sri Debilal Tudu was consuming electricity dishonestly and unauthorisedly in his Domestic premises by the way of direct hooking for from the nearby LT mains of WBSEDCL which resulted causing loss of revenue of WBSEDCL to the tune of load 0.5KW.

As theft of electricity was detected during inspection the illegal hooking line is disconnected & removed from the nearby electrical source and Single core Two wire PVC copper wire of black colour approx 45Ft route length along with hooking devices has been seized under memo of seizure list in the presence of witnesses but the accused person denied to sign on the Inspection Report and seizure list. The above seized materials duly packed and labeled at the inspection site but the accused person refrain to sign for the same. The inspection team left the aforesaid premises at about 01:20PM.

Thus the accused Sri Debilal Tudu, S/O-Lt. Ramsuraj Tudu, Vill- Salchura, P.S - Neturia, Dist- Purulia have committed an offence u/s135(1)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
