The undersigned would like to inform you that Sheds of SWM Unit at Hansapathar Containing 48 Nos GI sheet was stolen last night .The shed unit was inaugurated by the Block Deveelopment Officer of Neturia Dev. Block on 29/06/2024. Since then the unit has been running smoothly providing livelihoods to member of SHG Group at Hansapathar .It is noted that a solar pump was being fitted near the shed unit till 8 pm last night by the agency Kadir Sk along with his workers .Till then the shed was intact .The SHG group Members found the shed missing today at about 6 am .Such anti-social activity in this area is indeed very unfortunate for which the noble mission of SBM(G) has been hampered .

Under this circumstances, you are requested kindly to look into the matter seriously so that the stolen sheds may be recovered and culprits are arrested and punished as early as possible.
