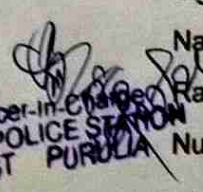

**Sub: Lodging of F.I.R of theft of Electricity against BASUDEB BAURI, S/o Krishnapada Bauri at his Domestic premises at Chapuri, P.S.-Para and thereby committed an offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.**

Dear Sir,

This is to inform you that, I Sri Sutanu Goswami, S/O – Sitesh Chandra Goswami, A.E. & Station Manager of Anara CCC, WBSEDCL received an information to the effect that Basudeb Bauri, S/o Krishnapada Bauri residing at Chapuri was committing theft of Electricity at his Domestic premises by bypassing electricity by means of tapping from incoming side of the service cable..

Acting on this information this day 23.07.2024, I along with Sri sayandeep Paul (JE - II), Spandan Maji (Sr. OE), Prabir Nandi (Spot billing supervisor) & Kalabaran Mukherjee (Spot bill reader) of Anara CCC had been to the house of Basudeb Bauri . He was not present at his house. His brother Rajen Bauri was present in the house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises.

The premises is a one storied building. The meter is installed at opposite side wall of the entrance of that premises. A notice was prepared duly signed by the consumer representative served upon the consumer and held inspection. During inspection, it was detected that, Basudeb Bauri had bypassed the electricity by means of tapping from incoming side of the service cable bearing meter No: G157860 in the name of Sri Basudeb Bauri at the said premises by bypassing electricity by means of tapping from incoming side of the service cable. Inspection also revealed that Basudeb Bauri was the actual user of the above mentioned service connection.

Immediately, on my direction the contractual worker (Goutam Bauri & Bapi Bauri )disconnected the above mentioned service connection and removed the Energy meter bearing SI no: G157860.

From the evidence so far collected from the inspection of the energy meter of Basudeb Bauri, it is well established that Basudeb Bauri was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

On inspection it is found that he was using the following apparatus :- 1) Led Light 10 Nos.(10\*10)=100w, 2) pump 1no =750w, 3) Fan 5 Nos. (5\*100)=500w, 4) TV 1 no. =250w, 5) cooler 1 no. 500w, 6) fridge 1 no 500 w,. Total (100+750+500+250+500+500)= 2600 Watt.

I, Sri Sutanu Goswami, AE & SM of Anara CCC prepared inspection report in his presence i.e. consumer representative (Rajen Bauri) and witnesses at the spot and load assessed as 2.6 KW.

I, Sri Sutanu Goswami, AE & SM of Anara CCC prepared Seizure list in respect of the said premises and meter in presence of the consumer representative and witnesses at the spot.

The inspection was held between 04.30 PM to 05.00 PM today after observing all legal formalities. It is well evident that accused Basudeb Bauri, S/o Lt. Krishnapada Bauri of Chapuri has committed offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR.
