I beg to submit that today (28.07.2024) during my Evening Mobile duty I received credible source information that one Tanmoy Tantubay (23 Yrs) S/o Ashis Tantubay of Vill-Bhagabandh, PS-Para, Dist-Purulia was selling huge quantity of Country Spirit in his house. Accordingly, I informed to O/C Para PS and as per his instruction in between 20.05 hrs to 20.35 hrs. I held raid in his house and found that the above noted person was selling Country Spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying Country Spirit fled away. I asked the above noted person to produce license for selling such Country Spirit, but he did not have any authorization or license in support of said Country Spirit. As such he committed offence/46A(c) BE Act 1909 so he was arrested him U/S 67 BE Act and also seized 09 (Nine) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which were selling in which 01 (one) bottle as sample under proper seizure list in presence of witnesses duly signed by them. The seizure process made with proper videography & the memory card also been seized as produced the accompanied constable. I also prepared seizure list and label in presence of witnesses duly signed by them. During the time of arrested maintaining all rules and guideline as laid down by NHRC/WBHRC and informed his family members.

The arrested accd. namely Tanmoy Tantubay (23 Yrs) S/o Ashis Tantubay of Vill-Bhagabandh, PS-Para, Dist-Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.
