Anil Karmakar, Village-Poradih, P.O.-Bhagabandh, P.S.-Puncha, Dist-Purulia, Pin- 723151 has committed theft of electricity under section-135 clause (1)(a) of the electricity act subsequently amendment act-2007 on 26.07.2024 at about 12:00 P.M.

I, Sri Saikat Mallick, S/O-Himadri Mallick, A.E & S.M of Puncha CCC along with 1) Sri Somnath Soren(J.E Gr-I) under puncha CCC, S/O-Lt. Pannalal Soren 2)Sri Sandip Mahato(Sr. O.E.) under Puncha CCC, S/O-Lt. Brindaban Mahato,3) Sri Soumajit Rakshit(O.E.) under Puncha CCC, S/O- Sanjit Kumar Rakshit, 4) Sukumar Dutta (Sr. T.S.H.) under Puncha CCC, S/O-Lt. Jitendranath Dutta, 5) Sri Sristidhar Mahato(Sr. T.S.H) under Puncha CCC, S/O- Lt. Ganesh Mahato and other technical staff attached to Puncha CCC entered the premises of Sri Tapan Karmakar ,S/O- Lt. Anil Karmakar, Village-Poradih,P.O.-Bhagabandh,P.S.-Puncha, Dist-Purulia ,Pin- 723151 a consumer of Puncha CCC having Consumer ID-242088955, Meter No-L4622735 and inspected his premises .During the inspection unauthorized drawal of electricity was detected by direct hooking from the nearest pole of W.B.S.E.D.C.L at his domestic premises under section 135(1)(a).

The accused person was consuming electricity dishonestly at his domestic premises by direct hooking from the nearest pole of W.B.S.E.D.C.L causing considerable revenue loss of W.B.S.E.D.C.L. From the above hooking system he uses the following electrical equipment-

1) Fan-04 nos(80 Watt each) 2) Light-06 nos(20 Watt each) 3) TV-01 no(80 Watt) 4) Fridge-01no(120 Watt) 5) Bulb-01no(100Watt).

The following items were seized from the house of the accused person-

1) 2 core flexible wire length -10 meter approx. 2) Hooking devices
Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 01:00P.M. On 26.07.2024. The accused person has committed an offence U/S 135 (1)(a) of E.A-2003 subsequently amendment E.A-2007.
