

In producing herewith one accd. person namely Amar Duary (34 yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, Dist-Purulia with seizure of 20(Twenty) Sealed plastic bottles Country spirit style as "Dil Khush" containing 375 ml. each which were seized and

labeled under proper seizure list.

I beg to submit that today (04.07.24) at 16:05 hrs while I SI Churamani Mandal along with C/887-Amit BAuri and HG/1423 Hemanta Baskey both of Puncha PS were performing Spl Mobile Duty vide Puncha PS GDE No-157 Dated 04.07.24 and acting on source information after consulting you at about 21:05 hrs reached near Badra village and held raid near Badra village beside main road accuse namely Amar Duary (34 yrs) S/0 Lt. Niranjan Duary of Vill -Poradhi PS- Puncha District- Purulia and found that the above noted person was keeping/selling liquor which were kept near Badra village beside main road on demand Amar Duary failed to produce any valid document/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents as such he committed offence / 46 A(c)BE Act 1909 and also 20 (Twenty) Sealed plastic bottles Country spirit style as "Dil Khush" containing 375 ml. each which were seized under proper procedure maintained U/S 105 & 185 BNSS and seizure list duly signed by accused & witnesses and labeled out of which 01 (One) bottle Dil Khush collected as a sample at the time of seizure, So I arrested on 04.07.24 at 21.35 hrs. U/S 67 BE Act. During arrest I followed all the guide lines of Ld Apex Court. NHRC & WBHRC and the ground of arrest was duly notified and informed has relative issued arrest memo and handed a copy of the same to arrestee.

The arrested accd person namely Amar Duary (34 yrs) s/o Lt. Niranjon Duary of Vill - Paradih PS -Puncha. Dist- Purulia has committed offense U/S 46A( c) BE Act. 1909 for unauthorized possession and sale of liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Amar Duary (34 yrs) s/o Lt. Niranjan Duary of Vill -Paradih PS -Puncha. Dist-Purulia under proper section of law.
