Sub: Prayer for lodging FIR.

Sir,

In producing herewith the seized 01 (One) 12 (twelve) wheeler truck (Orange Colored) bearing Reg. No. WB 33 C 7049 loaded with approx 20 (twenty) ton Wood log and Fire wood log which was said to be illegal and which was Seized from the possession the driver and his co associates namely (i) Montaz Ansary (33 Yrs) S/o- Mubarak Ansary of Vill- Kajoli, PS- Hura, Dist- Purulia (ii) Khirod Majhi (56 yrs) S/o- Lt. Damodar Majhi of Vill- Fasco, PS- Arsha, Dist- Purulia (iii) Manik Kumar (45 yrs) S/o- Lt. Bistu Kumar of Vill- Upar Kahan, PS- Joypur, Dist- Purulia, Seizure list before you.

The nub of the fact in a nutshell is that on 20.07.2024 while I, ASI Ashish Adhikary along with force (i) C/- 1266 Mohan Rajwar & (ii) C/- 1392 Pradip Kr. Pathak of Purulia (M) PS left the PS for performing mobile duty vide Purulia (M) PS GDE No- 1226 Dtd. 20.07.2024 in PS area. During my mobile duty, I received a tip off at 12:05 hrs that 01(One) suspicious Truck loaded with illegal wood log was going through Buridih village road under Purulia (M) PS area. Subsequently, I along with force proceeded towards Buridih village to work out the tip off. While I along with the force arrived there, we found that 01 (One) loaded Truck was proceeding towards Buridih village road. I along with the force intercepted the said Truck bearing Reg. No. WB 33 C 7049 loaded with approx 20 (twenty) ton Wood log and Fire wood log on Buridih village road near Buridih Maidan under Purulia (M) PS. I found that the said Truck as well as goods were identical as I received prior information. On being asked, the driver of the said Truck disclosed his name as (i) Montaz Ansary (33 Yrs) S/o- Mubarak Ansary of Vill- Kajoli, PS- Hura, Dist- Purulia and his other 02 co associates disclosed their name as (ii) Khirod Majhi (56 yrs) S/o- Lt. Damodar Majhi of Vill- Fasco, PS- Arsha, Dist- Purulia (iii) Manik Kumar (45 yrs) S/o- Lt. Bistu Kumar of Vill- Upar Kahan, PS- Joypur, Dist- Purulia. I asked them to produce the valid documents in respect of the Truck as well as the loaded wood logs. But they were not able to produce any kind of documents in respect of the said Truck as well as the loaded wood logs. On their request I gave them time to produce the valid documents and for the mean time I detained the said Truck loaded with wood logs at Purulia (M) PS compound. The above noted drivers and his co-associates also came to the PS along with the said vehicle. Later at about 14.45 hrs I again repeatedly asked them to produce the valid papers to support the legality of the loaded wood logs in the detained vehicle but they could not produce any valid documents in respect of the loaded wood logs in that detained truck.

It was ascertained that the driver and his co associates of the said truck loaded with the wood logs in cahoots with the owner of the Truck by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that they procured the detained wood logs by fraudulently or their by any means for transporting the same to run clandestine business. So I seized the 12 (twelve) wheeler truck (orange colored) bearing Reg. No. WB 33 C 7049 loaded with approx 20 (twenty) ton Wood log and Fire wood log under proper seizure list in presence of available witnesses duly signed by them. The seizure was done in between 14.55 to 15.15 hrs. Thereafter, I informed you about the whole fact and as per your kind direction I handed over the seized property to the malkhana officer.

Under the above facts and circumstances, therefore, pray you kindly take lawful action against the driver and his co associates namely (i) Montaz Ansary (33 Yrs) S/o- Mubarak Ansary of Vill- Kajoli, PS- Hura, Dist- Purulia (ii) Khirod Majhi (56 yrs) S/o- Lt. Damodar Majhi of Vill- Fasco, PS- Arsha, Dist- Purulia (iii) Manik Kumar (45 yrs) S/o- Lt. Bistu Kumar of Vill- Upar Kahan, PS- Joypur, Dist- Purulia and (iv) the owner of the said truck under proper section of Law.
