Most Respectfully Sheweth:-

1. That, Complainant happens to be a local resident of Vill+ P.O- Kaluhar, P.S- Para, Dist- Purulia(W.B).
2. That the complainant happens to be a bus driver by profession, on 06.04.2024 at about 11 p.m when he was in the bus his mobile bearing IMEI No. 863175060583446 / 863175060583453 got theft near Golkunda More under Purulia (M) P.S, Dist- Purulia (W.B).
3. That regarding the matter he lodged a complaint before the Purulia (M) P.S on 16.04.2024 based on which the P.S lodged a P.S G.D. no. 928/24 dated 16.04.2024.
4. That in his mobile G-Pay and Phone Pay were installed linked with his mobile number and bank account.
5. That later when he went to his bank for withdrawing money from his bank account he came to know that using his mobile phone and sim card some miscreants/ hacker theft by withdrawal/ transfer about Rs.1,57,000/-(Rupees one lakh fifty seven thousand only) from his bank account linked with the mobile number , G-Pay and Phone Pay accounts.
6. That being perplexed the complainant submitted a written complaint before the Purulia (M) P.S regarding the matter, but the P.S denied taking the complaint. Later the matter has been informed to the I.C Purulia (M) P.S, Purulia in writing, through registered post on 05.06.2024 which was delivered to the Police Station on 06.06.2024 and the P.S is well posted with the matter, but for reasons unknown no legal action or F.I.R has been lodged against the accused persons and for investigation.

That later getting no other alternative the matter has been informed in writing to the Superintendent of Police, Purulia on 20.06.2024 but till date no legal initiatives has been taken by the Office concerned hence the complainant had no other alternative but to approach before the Ld. Court of Law to file this petition praying for taking necessary action against the accused persons who has committed illegalities and theft his entire savings from his bank account.
8. That, proper Police investigation should be taken up by treating this complaint as F.I.R and action should be taken against the accused persons as per Law for the Interest of Justice.
9. That, as I.C Purulia (M) Police Station, Purulia in spite of getting specific information/ complaint from the complainant has not instituted any F.I.R against the accused persons nor any initiative has been taken from the Office of the Superintendent of Police, Purulia, let this complaint be forwarded to I.C Purulia (M) Police Station, Purulia for treating the same as F.I.R and for undertaking investigation.
10. That as required all the formalities of Lodging Complain U/S- 154 Cr.P.C, U/S- 154(3) Cr.P.Code has duly been complied with by the complainant. But yet no F.I.R has been lodged against the accused persons.
