In producing herewith the arrested accused person SK. Rajib (41 Yrs) S/o-Lt. SK. Faruk of Vill- Hutmura, PS- Purulia (M), Dist- Purulia and beg to report that on 28.07.2024 at about 04:45 hrs. During night mobile duty I received a source information regarding presence of the above noted proclaimed accused person at Hutmura bus stand under Purulia (M) PS. Accordingly, I informed the matter to you and diarized the fact in GD vide Purulia (M) PS GDE No- 1676 Dtd. 27.07.2024 As per direction I along with (i) C/- 2078 Haripada Das & (ii) C/664 Sahebram Soren (iii) C/154 Rajib Nag arrived at Hutmura Bus Stand, to work out the source input. On arrival at about 05:15 hrs I along with the force reached Hutmura Bus Stand. Subsequently, we held raids against the said accused person and managed to apprehend him from Hutmura Bus stand. On interrogation he confessed that he had every knowledge regarding proclamation and attachment completed against him but knowingly he was avoiding Court order by remaining absconding. Accordingly I arrested him on 28.07.2024 at 05.15 hrs by preparing proper Memo of Arrest observing all legal formalities for violating order issued by the Ld. Court. I searched for him but found nothing except his wearing apparels. I informed his family members. Arrest accused person Sk. Rajib forwarded to Ld. Court on the strength of W/A in c/w above noted reference under proper Police escort and all connected papers. Arrested accused treated as absconder vide S.P. Purulia Memo No 85/(V) Dated 11.01.2024 & District absconder S.L No- 37/24.

It is also noted here that as per order of Ld. Court and proclamation order had been served against them as follows-
