Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Haripada Majhi (48 Yrs) S/o- Lt. Haren Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia and seized articles (i) 20 (Twenty) numbers of sealed bottles of Country Sprit styled as Kingfisher Imperial Strong Bear containing 650 ml each (ii) 06 (Six) bottles of County Sprit styled as McDowell's No- 1' containing 180 ml each along with seizure list and Memo of Arrest.

I beg to state that today (28.07.2024) during my day mobile duty at about 11.15 hrs I, ASI Majibur Rahaman of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a Line Hotel under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 1147 Bappaditya Nandi & C/- 2498 Ranjan Kr. Samanta of Purulia (M) PS vide GDE No- 1716 Dtd. 28.07.2024 rushed to the spot i.e. the Gouri Line Hotel, beside the Purulia to Ranchi Pitch Road near Lagda village under Purulia (M) PS at 11.55 hrs. After arriving at that spot and as per your instruction we conducted a raid in the Gouri Line Hotel. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Haripada Majhi (48 Yrs) S/o- Lt. Haren Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his Line Hotel for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized (i) 20 (Twenty) numbers of sealed bottles of Country Sprit styled as Kingfisher Imperial Strong Bear containing 650 ml each (ii) 06 (Six) bottles of County Sprit styled as McDowell's No- 1' containing 180 ml each. In which 02 sealed bottles were taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made in between 12.05 & 12.25 hrs.

I also arrested the involved accused person namely Haripada Majhi (48 Yrs) S/o- Lt. Haren Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia at 12.30 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Haripada Majhi (48 Yrs) S/o- Lt. Haren Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia under proper section of Law.
