

Sub: Prayer for lodging FIR.



I beg to state that today (14.07.2024) during my special mobile duty at about 10.25 hrs I, SI Mekdam Sabab of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a Chicken Shop at Chunardih morh under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 2734 Susanta Panda & C/- 1147 Bappaditya Nandi of Purulia (M) PS vide GDE No- 839 Dtd. 14.07.2024 rushed to the spot i.e. Chunardih morh at 11.25 hrs. After arriving at that spot and as per your instruction we conducted a raid in the Poultry Chicken Shop. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Bivishan Mahato (25 Yrs) S/o- Biru Mahato of Vill- Chunardih, PO-Sindurpur, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his shop for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized (i) 06 (Six) numbers of sealed bottles of Country Spirit style as 'McDowell's No-I', containing 375 ml each (ii) 13 (Thirteen) numbers of sealed bottles of Country Spirit style as 'Kingfisher' imperial strong beer, containing 650 ml each. In which 02 sealed bottle were taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made in between 11.35 & 12.05 hrs. I also arrested the involved accused person namely Bivishan Mahato (25 Yrs) S/o- Biru Mahato of Vill- Chunardih, PO- Sindurpur, PS-Purulia (M), Dist-Purulia at 12.05 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Bivishan Mahato (25 Yrs) S/o- Biru Mahato of Vill- Chunardih, PO- Sindurpur, PS- Purulia (M), Dist-Purulia under proper section of Law.
