Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Binash Mahato (32) s/o Jyotilal Mahato of Vill- Aimondih, PS- Purulia (M), Dist- Purulia and seized articles (i) 29 (Twenty Nine) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each (ii) 14 (Fourteen) numbers of sealed bottles of 'CAPTAIN' containing 600 ml each (iii) 07 (Seven) numbers of sealed bottles style as Mc. Dowells No-I, containing 375 ml each (iv) 06 (Six) numbers of sealed bottles style as Mc. Dowells No-I, containing 180 ml each along with seizure list and Memo of Arrest.

I beg to state that today (27.07.2024) during my Night mobile duty at about 19.05 hrs I, ASI Ramnath Gorain of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a Shop at Aimondih morh under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 229 Asilt Malla & C/- 06 Debdas Mukherjee of Purulia (M) PS vide GDE No-1676 Dtd. 14.07.2024 rushed to the spot i.e. in Aimondih morh at 19.40 hrs. After arriving at that spot and as per your instruction we conducted a raid in the Shop of Binash Mahato. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Binash Mahato (32) s/o Jyotilal Mahato of Vill- Aimondih, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his Shop for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, (i) 29 (Twenty Nine) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each (ii) 14 (Fourteen) numbers of sealed bottles of 'CAPTAIN' containing 600 ml each (iii) 07 (Seven) numbers of sealed bottles style as Mc. Dowells No-I, containing 375 ml each (iv) 06 (Six) numbers of sealed bottles style as Mc. Dowells No-I, containing 180 ml each. In which 04 sealed bottle were taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made in between 19.48 & 20.02 hrs.

I also arrested the involved accused person namely Binash Mahato (32) s/o Jyotilal Mahato of Vill- Aimondih, PS- Purulia (M), Dist- Purulia after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Binash Mahato (32) s/o Jyotilal Mahato of Vill- Aimondih, PS- Purulia (M), Dist- Purulia under proper section of Law.
