Sarkar Road, Purulia begs to inform you that the lands described in Schedule below previously belonged to and owned and possessed by my father Gangaram Sarawgi, since deceased, who acquired the same from its owners and title holders and the same has been duly recorded in his name in R. S. Record of Right. It is submitted that during his life time, Gangaram Sarawgi settled the schedule lands including others landed properties to his six sons including me by executing and registering a Family Settlement Deed.

I am to inform you that one Uttam Sahish (PAN – RMLPS4842A) S/O Late Sahadeb Sahis, by caste Hari, Hindu by faith of Deshbandhu Road, Purulia, P. O and P. S Purulia, District Purulia execute and registered a General Power of Attorney bearing No. 4177 of 2023 in respect to the lands mentioned in Schedule below in favour of one Sri Sanjay Singh Deo (PAN-AYXPS3852K) S/O Late Sushanta Singh Deo, Hindu by faith, Business by occupation, a resident of Village Mahukuda, P. O Bagbinda, P. S. Jhalda, District Purulia and in the aforesaid Power of Attorney, Uttam Sahish claimed that he has purchased the Scheduled land from Gangaram Sarawgi, i.e. my deceased father, by a Registered Deed of Sale No. 5630 dated 10. 10. 1995 which was allegedly registered at the Office of DSR Purulia.

O and P. S and District Purulia, the Witnesses of the aforesaid Deed and along with some other persons with an aim to illegal gain and also cause heavy financial loss to me.

It is submitted that Uttam Sahish and others as mentioned above including Sri Sanjay Singh Deo, the Power Holder, forged documents for illegal gain, and the forged documents have been placed before the Settlement Authority for mutation and also placed before other persons to sell out the scheduled lands though Uttam Sahish and others as mentioned above have every knowledge that the Sale Deed No. 5630 dated 10. 10. 1995 allegedly executed by Gangaram Sarawgi is forged one.

In the aforesaid circumstances I am requesting before your kindness to start a specific criminal case or cases against the aforesaid accuse persons and take legal action against the accused persons as per the law and keep them behind the bar for their wrongful and illegal activities.
