In producing here with arrested accused persons namely (1) Anuj Kumar (25 yrs) S/O- Harinam Singh of 25 Prathvipur, P.O- Bilawan, PS- Ajeetmal, Dist- Auraiya, U.P- 206121, (2) Shivam Singh (23 yrs) S/O- Narendra Singh of Hukumpur Dera, PO- Saanfar, PS- Ajeetmal, Dist- Auraiya, U.P- 206121, (3) Niraj Singh (24 yrs) S/O- Lt. Chob Singh of Kishanpur, P.O- Dahgaon, PS- Dibiyapur, Dist- Auraiya, U.P- 206246, (4) Raghvendra Singh (26 Yrs) S/O- Shiv Kumar Singh of Prathvipur, PO- Bilawan, PS- Ajeetmal, Dist- Auraiya, U.P- 206121, (5) Jitendra Singh (27 Yrs) S/O- Lt. (2) 04 (Four) pcs. Iron made Tarawal having wooden butt length approx each 1 ft. 6 inch, (butt length approx 05 inch each) (3) 01 (One) Iron made Sabal length approx 1 ft. 10 inch, (4) 01 (One) Nylon rope length approx 15 ft., (5) 01 (One) TATA Punch Car (Ash Colour) Bearing Regd. No- UP79Z 8024, (6) 01 (One) black-red colour TVS Apache Motor Cycle Bearing Regd. No- UP79AC 4554, (7) Total 5 (Five) numbers Android Mobile Set and 01 (One) Key Pad Mobile Phone lodged complaint against them and some others to the effect that on 29.07.2024 at about 22:25 hrs in course of Night Patrolling Mobile Duty vide Purulia (T) PS GDE No-2332 dated - 29.07.24 and C.C. No-2150/2024 dated-29.07.24 received a credible information from duty officer of Purulia (T) PS which was noted vide Purulia (T) GDE No- 2343 dated-29.07.24 that a gang of dacoits being armed with deadly weapons assembled at Siyalkheda math beside the Rail line (open place) ward no-16, Dhobghata and they were preparing themselves for committing dacoity under Purulia (T) PS area. Accordingly as per direction of I/C Purulia (T) PS and duty officer over phone myself along with C/253 Arabinda Mallick and C/950 Mathur Mandal & PC Party team proceeded to work out the information by a Govt. vehicle, and reached at Siyalkheda math beside Rail line (open place) ward no-16, Dhobghata at 22:45 hrs reached at anticipated place and we noticed in a glimpse of light that a gang of 09/10 persons in & beside a four wheeler vehicle & one motorcycle assembled at Siyalkheda math beside Rail line (open place) ward no-16, Dhobghata and those persons were whispering from which it was cleared that they were preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them as well as both the vehicles very closely. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed to ours words and tried to flee away. We succeeded to nab in rounding up only 06 (six) of them at 22:55 hrs while the rest were managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them that we want to search them as well as their vehicles and if necessary they can search us, but they informed us that they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered and seized (1) One Iron rod approx 4 ft.

(2) 04 (Four) Pcs. Iron made Tarawal having wooden butt length approx each 1 ft. 6 inch (butt length approx 65 inch each), (3) 01 (One) Iron made Sabal length approx 1 ft. 10 inch, (4) 01 (One) Nylon rope length approx 15 ft., (5) 01 (One) TATA Punch Car (Ash Colour) Bearing Regd. No- UP79Z 8024, (6) 01 (One) black-red colour TVS Apache Motor Cycle bearing No- UP79AC 4554, (7) Total 5 (Five) numbers Android Mobile Set and 01 (One) Key Pad Mobile Phone from the possession of the arrested accused persons as noted above from the vehicles in between 23:00 hrs to 23:15hrs. I arrested above noted 06 (six) persons. Issued Memo of arrest and observe all legal formalities of arrest, also inform them regarding ground of arrest and inform to their family members. On interrogation they confessed their guilt and they stated that they have assembled with intention to commit dacoity with assist some local criminals.

I am to note here that I have to conduct search & seizure under proper videography in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity armed with deadly weapons which might be dangerous for life of public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities, I arrested them after preparing arrest memo and ground of arrest were duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Anuj Kumar (25 yrs) S/O- Hariram Singh of 25 Prathvipur, Bilawan, PS- Ajeetmal, Dist- Auraiya, U.P- 206121, (2) Shivam Singh (23 yrs) S/O- Narendra Singh of Hukumpur Dera, PO- Saanfar, PS- Ajeetmal, Dist- Auraiya, U.P- 206121, (3) Niraj Singh (25 yrs) S/O- Lt. Chob Singh of Kishanpur, PO- Dahgaon, PS- Dibiyapur, Dist- Auraiya, U.P- 206246, (4) Raghvendra Singh (26 Yrs) S/O- Shiv Kumar Singh of Prathvipur, PO- Bilawan, PS- Ajeetmal, Dist- Auraiya, U.P- 206121, (5) Jitendra Singh (27 Yrs) S/O- Lt.
