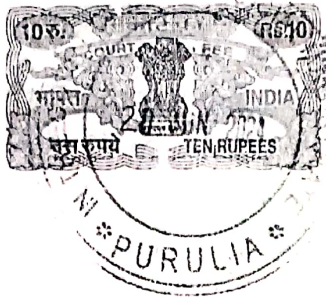

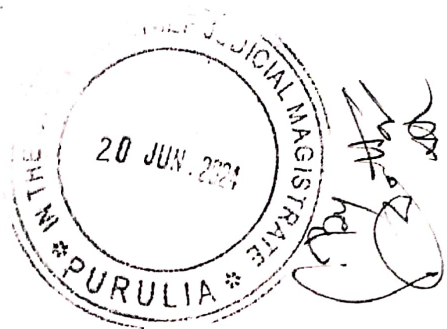

The above named complainant beg to state as follows:-

[1] That the complainant is the legally married wife of the Accused No.1 namely Sourav Bouri and their marriage was solemnized on 26/02/2024 as per Hindu rites and customs and as per demand father of the complainant gifted a sum of Rs.1,00,000/- and 3 Bhari gold ornaments and 10 bhari of Silver ornaments Almira, Utensil and etc. and the marriage was a negotiable marriage.

- [2] That the marriage was held on the house of the Rajkumar Bouri Deshbandhu road, Purulia town, Purulia and after marriage both are live as husband and wife in her matrimonial home at village- Shitalpur, Purulia and their marriage has been conjured.
- [3] That, after marriage when she was residing at her matrimonial home the accused persons used to objectable language and also taunted aiming the parents of the complainant of the gifted articles but the complainant did not any protest and the other hand complainant was compelled to do all the house hold works and the part of the complainant found any error then the Accused parsons used to assaulted the complainant by hunter also used filthy language.
- [4] That the accuse No.1 is husband, accused No. 2 & 3 are the father-in-law and mother-in-law and accused No. 4 is the Sister-in-law of the petitioner.
- [5] That the accused persons after making criminal conspiracy to each other put pressure to the complainant to bring a sum of Rs.50,000/- from her father, which is require to develop the business and complainant intimated the same to her father then the father of the complainant expressed his inability to meet any further demand hearing the news the accused persons stopped speaking with the complainant and behalf like a maid servant, not to give proper food medicine, cloth etc. and not to allow her husband's room as a result the life of the complainant is exhausted. Thereafter on dated 05/06/2024 and drove her out after assaulting the accused persons then the complainant anyhow came to her father's house and stated all the facts and on the next date parents and witness had been to the house of the accused persons and requested the accused persons refused to keep her in house without payment of further demand.
- [6] That the complainant went to the Purulia (M) Police Station and reported the matter to police personal and came to learn no case has been started against the accused persons then the complainant informed the matter to S.P. Purulia on 06/06/2024 but off no good. Now for getting appropriate relief the complainant file this case for proper legal action against the accused and this is the caused for delay.
- [7] That, the accused persons have committed a Criminal offence and they are liable to be punished accordingly.

It is therefore prayed before your Honour would be pleased to direct the Officer-in-Charge Purulia (M) P.S. for investigation of the case against the Accused person's by treating this complain as F.I.R. provide U/s 156 Cr. P.C.
