Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Parimal Mahato (52 Yrs) S/o- Lt. Jagindranath Mahato of Vill- Kustuka, PS- Purulia (M), Dist- Purulia and seized articles 28 (Twenty Eight) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (05.07.2024) during my day mobile duty at about 13:05 hrs I, SI Mekdam Sabab of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a house of Kustaur village under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force (i) C/- 664 Sahebaram Saren & (ii) HG- 1576 Shaktipada Mahato all of Purulia (M) PS vide GDE No- 233 Dtd. 05.07.2024 rushed to the spot i.e. Kustaur village at 13:45 hrs. After arriving at that spot and as per your instruction we conducted a raid in the suspected house. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Parimal Mahato (52 Yrs) S/o- Lt. Jagindranath Mahato of Vill- Kustaur, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his house for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized articles 28 (Twenty Eight) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each. In which 01 sealed bottle was taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 13:55 & 14:15 hrs.

Accordingly, I arrested the involved accused person namely Parimal Mahato (52 Yrs) S/o- Lt. Jagindranath Mahato of Vill- Kustaur, PS- Purulia (M), Dist- Purulia at 14:15 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Parimal Mahato (52 Yrs) S/o- Lt. Jagindranath Mahato of Vill- Kustaur, PS- Purulia (M), Dist- Purulia under proper section of Law.
