Subject - Regarding Threat to Life, Property and Illegal Trespass

Respected Sir,

I, Biswanath Koiborto s/o Late Gangadhar Kolborto resident of Thekara; Post Godi Bero, Raghunathpur, District Purulia, West Bengal 723133. I work as a guard at ChandiMandir and take care of the Chandi Mela ground area which includes 4955 of Paschim Bero area. I would like to bring to your notice criminal activities of 1. Jaidev Majee s/o Amulya Majee 2. Moushumi Majee w/o Buddhadeb Majee 3. Surojit Choudhury S/O Krishnakishore Chaudhury 4. Sadhan Paramanik s/o Umapada Paramanik all residents of Puratan Bero, Post Godi Bero , Raghunathpur 5. Trilochan Majee s/o Kanhailal Majee of Village Bagicha , Post Gadi Bero ,Raghunathpur, District Purulia and others.

I am the guard of Chandi Mandir and Chandimela ground, of Mouza Paschim Bero, Post Godi Bero. Today i.e. 09.07.2024 at around 10 AM suddenly the above mentioned accused people along with others forcefully entered the Chandimela Ground. When I tried to stop them I was threatened that if I stopped them I would be murdered. They stated they will forcefully enter and stay there as well and no one can stop them. The accused number 1 i.e. Jaidev Majee caught me by my neck and pushed me to the ground. The mentioned accused people ghereed me and abused me in filthy language. They stated they don't require any permission to use the land and they will forcefully use the land. The accused mentioned above are habitual offenders, especially accused number 1 whose only intention is to forcefully occupy the chandimela ground. Fearing my life i somehow ran away from there/

In view of the above I request you to please take strict action against the accused and ensure stringent punishment is awarded.
