Sub : Prayer for lodging FIR against the arrested accused person namely Manoranjan Mahata (32 yrs), S/O Mathur Mahata of Vill. - Asurbandh, PS-Santalaldih Dist- Purulia.

Sir,

In producing herewith the arrested accused person named as Manoranjan Mahata (32 yrs), S/O Mathur Mahata of Vill. - Asurbandh, PS-Santalaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 04.07.2024 at about 19.25 hrs, while performing evening mobile duty, I received a source information to the effect that the ID liquor has been kept at Asurbandh village near Deoli Panchayet more under this PS in the shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with SI Habibur Rahman and force left for Asurbandh village near Deoli Panchayet to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the shop styled as 'Raj hotel' of the above noted Manoranjan Mahata at Asurbandh village near Deoli Panchayet, P.S. Santaldih at about 19.55 hours. Seeing police party some unknown persons in front of the said shop were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the ID liquor for selling and he is the owner of the said shop. However, I along with force, said accused started a search with proper videography inside the said shop and found the following item in the said house -

- 1) 08 bottles Kingfisher each bottle containing 600 ML
- 2) 07 bottles McDowells No. 1 each bottle containing 180 ML.
- 3) 04 bottles McDowells No. 1 Rum each bottle containing 180 ML
- 4) Budweiser 08 bottles each bottle containing 330 ML
- 5) 03 bottles Imperial Blue each bottle containing 180 ML
- 6) 10 bottles Dil Khush each bottle containing 600 ML.

From Sl. No. 1 to 6, one (01) bottle from each taken as sample

I interrogated him about the purpose of the stocking and possessing such liquor. He replied it was the business of him. On repeated question he told that the person who fled away his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper seizure list with proper videography in between 20.25 hrs and 20.45 hrs & took up one (01) bottle from each brand taken as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit liquor illegally without any valid papers in the hotel has prima-facie been made out and for the interest of proper investigation, I arrested the above accused person at 21.05 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the accused Manoranjan Mahata (32 yrs), S/O Mathur Mahata of Vill. - Asurbandh, PS-Santalaldih Dist- Purulia.
