Sub: Prayer for lodging FIR against the arrested accused person namely Bablu Bauri (39 yrs), S/O Lt. Barun Bauri of Vill. - Kanki Basti, PS-Santaldih Dist-Purulia.

Sir.

In producing herewith the arrested accused person named as Bablu Bauri (39 yrs), S/O Lt. Barun Bauri of Vill. Kanki Basti, PS-Santaldih Dist-Purulia along with seizure – list and seized items as described below, I beg to state that on 19.07.2024 at about 10.05 hrs, , I received a source information to the effect that the ID liquor has been kept at Kanki Hattola under this PS in the shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with and force left for Kanki Hattola to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the unnamed shop of the above noted Bablu Bauri at Kanki Hattola P.S. Santaldih at about 10.25 hours. Seeing police party some unknown persons in front of the said shop were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the ID liquor for selling and he is the owner of the said shop. However, I along with force, said accused started a search with proper videography inside the said shop and found the following item in the said house -

- 55 bottles Dilkhush each bottle containing 600 ML 1)
- 13 bottles Dil Khush each bottle containing 375 ML. 2) From Sl. No. 1 to 2, one (01) bottle from each taken as sample

I interrogated him about the purpose of the stocking and possessing such liquor. He replied it was the business of him. On repeated question he told that the person who fled away his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper seizure list with proper videography in between 10.45 hrs and 11.05 hrs & took up one (01) bottle from each brand taken as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit liquor illegally without any valid papers in the hotel has prima-facie been made out and for the interest of proper investigation, I arrested the above accused person at 11.10 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the accused Bablu Bauri (39 yrs), S/O Lt. Barun Bauri of Vill. – Kanki Basti, PS-Santaldih Dist-Purulia.
