Sub: Complaint against Kriesnendu Hari (37 Yrs) S/O-Lt. Gohan Hari of Garsika village, P.S - Santuri, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accused person namely Kriesnendu Hari (37 Yrs) S/O-Lt. Gohan Hari of Garsika village, P.S - Santuri, Dist - Purulia along with one loaded jarican containing 10 (Ten) Ltrs "Chalai" & 08 (Eight) steel glass with a plastic bag seized under proper seizure list, I beg to submit that today (28.07.24), I along with force while performing evening mobile duty at about 19:25 hrs received a credible source information that one person Kriesnendu Hari (37 Yrs) S/O-Lt. Gohan Hari of Garsika village, P.S - Santuri, Dist - Purulia was stocking and selling "Chalai" from his house at Vill- Garshika, P.S - Santuri, Dist - Purulia. I informed to OC Santuri PS about this matter & as per direction, I along with force reached at his house of Kriesnendu Hari at about 20:15 hrs at Garshika village to work out the source information and held raid there. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person was stocking "Chalai" for sell. On demand, he failed to produce any valid documents in respect of selling and stocking of Chalai. Accordingly, I seized and labeled one loaded jarican containing 10 (Ten) Ltrs "Chalai" & 08 (Eight) steel glass with a plastic bag under proper seizure list duly signed by the witnesses. I had done video & audio recorded whole Seizure process & labeled with my mobile. Then, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Kriesnendu Hari (37 Yrs) S/O-Lt. Gohan Hari of Garsika village, P.S - Santuri, Dist - Purulia.
