Lodging an FIR regarding death of an unknown person at Beniasole under Adra PS Sub: jurisdiction on 05,06.24

Sir,

I, Shri Subir Kumar Pal, I.C. Adra PS do hereby lodge complaint suo moto against unknown person to the effect that on 05.06.24 at 11.25 hours on receipt of source information regarding an unknown dead body lying at Beniasole behind Samrat Lodge under the jurisdiction of Adra Police Station, I rushed to the spot after taking all informative actions and at around 11.45 hours I reached on spot. Before my arrival on spot, SI Soumik Acharya of Adra PS also had reached there. On reaching at the spot I found an unknown person (About 32 years) wearing a green colour half pant lying on the ground in the secluded bushy area at a distance about 150 meters in the North West direction from 'SAMRAT LODGE'. Coordinates of the place is Lat: 23 30'5.436" N Long: 86 40'21.828" E. The person was found unconscious and he was found bowing his knees and head to the ground heading towards West. No seize worthy materials were found around the place and observing the condition of the person it seemed that the person was dead. However he was sent to Raghunathpur S S D Hospital through SI Soumik Acharya to ascertain the fact and to take further course of action. On returning to PS message was given with photos for identification of the person to all concerned in Charges of Police Station of West Bengal. IC MPB, Purulia, OC, MPB, CID Bhawani Bhawan and the SHOs of Bihar and Jharkhand.

The person was taken to Raghunathpur S S D Hospital at 12.30 hours, the on duty medical officer after examining the person declared him dead and then Sandeep Murmu - the Facility Manager of the hospital made a requisition to IC Raghunathpur PS for taking necessary action. Over this information, an UD case no. 62/24 dated 05.06.24 was started at Raghunathpur PS and SI Prabir Kumar Dey of Raghunathpur PS in course of causing enquiry of the UD case prepared Surathal Report over the dead body in presence of following witnesses 1) Sandeep Murmu - the facility manager, 2) SI Soumik Acharya of Adra PS 3) Constable: 604 Chandra Sekhar Singh of Raghunathpur PS and sent the dead body to Deben Mahata Govt. Medical College & Hospital, Hatuara, Purulia under escort of Constable: 1055 Shantimoy Samanta of Raghunathpur PS with proper dead body Challan for holding post mortem examination over the dead body of the deceased to ascertain the actual cause of death and prayer was also made by the EO to preserve the dead body as per Govt. Rules.

The Xerox copy of Post Mortem report (No. 593/24 dt 06.06.24) of the above noted unknown person was received at this PS from IC Raghunathpur PS today and on perusal of the PM report it came to light that the death of the unknown person was due to the effects of manual strangulation ante mortem in nature and homicidal in manner. There are also evidences of ante mortem smothering which is also homicidal in nature. The date and time of receipt of the dead body at the hospital where PM was done is on 06.06.24 at 13.15 hours. Time passed since death might be within 06 to 24 hours prior the receiving time of the dead body at the police morgue of DMGMCH, Purulia,

Under these circumstances, it can be concluded that the unknown person recovered from the place mentioned above was killed by some person(s) on the intervening night of 04.06.24 and 05.06.24 at any time and hence I registered Adra PS case no. 69/24 dated 16.08.24 n/s 302/34 IPC was started and endorsed the case to SI Gour Hari Ghosal for causing its investigation.
