Sir,

In producing here with one arrested accused Bhateswar Mahato (32 yrs) S/O- Khedan Mahato of vill- Rugri, P.S.-Arsha Dist-Purulia, along with following seized articles.

1) One white colour plastic container with approx 17 ltrs. of ID liquor.

(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Animesh Pati of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 26.08.2024 at about 14.05 hrs. during my evening mobile duty at PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his house at Rugri village. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with i) C/-1405 Biswanath Singh Sardar and ii) C/- 239 Kajal Kuiry of SAP 7th BN camp at Arsha PS, rushed in the house of Bhateswar Mahato (32 yrs) S/O- Khedan Mahato of vill- Rugri, P.S.-Arsha Dist-Purulia to work out the information vide Arsha PS GDE No. 1194 & CC No. 3042 Dtd. 26.08.2024. Reaching at Rugri village at about 19.25 hrs we fixed-up in the house of above noted accd. person Bhateswar Mahato (32 yrs) S/O- Khedan Mahato of vill- Rugri, P.S.-Arsha Dist-Purulia and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. It took time from 19.35 hrs. to 19.45 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 19.55 hrs after observing all the formalities issuing memo of arrest.

I therefore pray that a specific case may kindly be started against the accused Bhateswar Mahato (32 yrs) S/O- Khedan Mahato of vill- Rugri, P.S.-Arsha Dist-Purulia under proper section of law.
