Sir,
In producing herewith one arrested accused person Surja Kumar (28yrs) S/O- Khaku Kumar of vill- Satra, P.S.-Arsha, Dist-Purulia along with following seized articles.

- 1) 05 Bottle of country sprite marks as "Dil Se", 600 ML each bottle & Rs-55/- each bottle (05=275/-)
(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- 2) 05 Bottle of country sprite marks as "Dil Khus", 600 ML each bottle & Rs-55/-each bottle (55x05=275/-)
(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- 3) 06 Bottle of country sprite marks as "Dil Se", 375 ML each bottle & Rs-35/- each bottle (35x06=210/-)
(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)

I, ASI Amal Kr. Pati of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 22.08.2024 at 17.25 hrs. during my anti crime evening mobile duty at Arsha PS area. I received, source information over telephone that the above noted accused was selling ID liquor at Satra village under Arsha P.S. On receiving the source information, I communicated with O/C Arsha PS over telephone. As per direction of O/C, Arsha P.S I along with C/- 1479 Anup Mahato of Arsha P.S and C/- 226 Bittu kr. Singh of SAP 7th BN, camp at Arsha P.S work out the information vide Arsha PS GDE No. 1012 & C.C. No. 3003 dtd. 22.08.2024. Reaching at Satra village at about 18.05 hrs, we fixed-up in the house of Surja Kumar (28yrs) S/O- Khaku Kumar of vill- Satra, P.S.-Arsha, Dist-Purulia found that selling of Country sprite, Foreign liquor was going on there and having seen police all customers managed to escape, but we were able to apprehend the above noted accused person namely Surja Kumar (28yrs) S/O- Khaku Kumar of vill- Satra, P.S.-Arsha, Dist-Purulia who was selling foreign liquor, Country sprite and I.D Liquor which he use to sell clandestinely to make his profit. On demand he failed to produce any valid documents in support of selling Country Spirit. Accordingly, I seized all those articles after preparing a proper seizure list and put label on all the seized articles from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and one bottle of that seizure was taken as sample which was also duly labeled. It took time from 18.15 hrs. to 18.35 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 18.45 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Surja Kumar (28yrs) S/O- Khaku Kumar of vill- Satra, P.S.-Arsha, Dist-Purulia under proper section of law.
