**Sub: FIR for theft of electricity.**

Dear Sir,

I Sri Goutam Kr. Mandal, S/O- Late Chinta Mani Mandal, Age- 38years, Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by the electricity act 2003 against Sri Maheswar Hembram, S/O- Late Kushal Hembram of Village -Mahultanr, PO-Chatuhansa, PS- Arsha, Dist- Purulia for committing offence of theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 27.08.2024 at about 13:00 o'clock I, along with Sri Partha Chakarabarty, S/O-Late Dinbandhu Chakarabarty, Divisional Engineer(E), S&LP, Purulia Regional Office, Sri Dayamoy Mahato, S/O-Late Chhutulal Mahato, Sr. TSH, Purulia Regional Office, Sri Rajesh Kumar, S/O-Late Gulo Ram, Junior Engineer(E), Gr-I, Arsha CCC, and Sri Alimuddin Ansary, S/O- Late Miyazan Ansary, Sr. TSH, Arsha CCC, employees of WBSEDCL went to routine inspection at Village - Mahultanr Chatuhansa where we have found that accused Sri Maheswar Hembram, S/O- Late Kushal Hembram was enjoying electricity by direct hooking unauthorisedly from nearby LTOH of WBSEDCL, for his domestic purposes.

During inspection the accused Sri Maheswar Hembram was away from home but his mother failed to explain about such unauthorised activity.

Thereafter we have prepared the inspection Report duly signed by the witnesses and disconnected the hooking arrangement from nearby LTOH line of WBSEDCL and seized single core two wire pvc aluminium cable of 10 feet(approx.) length under proper seizure list duly signed by the witnesses.

After completion of our inspection and seizure we have left the premises at about 13:20 o'clock.

Therefore, you are requested to take lawful action against the accused Sri Maheswar Hembram, S/O- Late Kushal Hembram of Village -Mahultanr, PO-Chatuhansa, PS- Arsha, Dist- Purulia for committing offence of theft of electricity U/S 135(i) (a) of the electricity act 2003 with up to date Amendment by treating this written complaint as FIR.


