- 2.. That thereafter your complainant fell down into the ground with senseless condition thereafter seeing my senseless condition took away Sikabat Hospital for treatment and thereafter my sense is/was regain that I am

and came, to know that . . . your complainant admitted at Sirkabab Hospital for treatment and after primary treatment seeing my condition the Doctor of Sirkabab Hospital advise and to refer Purulia Govt. Medical College Hospital for better treatment and thereafter your complainant went to Purulia Govt. Medical College & Hospital for treatment and thereafter seeing the condition of your complainant the Doctor of Deben Mahato Govt. Medical College and Hospital admitted in to the said Hospital on 15/5/24 at 15.15 P.M. and thereafter your complainant admitted and treated from 15/5/24 to 18/05/24 and thereafter discharge your complainant on 18/05/2024 and the Discharge certificate enclosed herewith.

4... That thereafter your complainant is very weak and not to fit physically and mentally for some days / weeks but thereafter your complainant orally inform the matter to the Arsha Police Station but Arsha P.S. police did not take any action against the accused persons.

5. That thereafter some days/week wise your complainant fit to walk more and therefore, thereafter your complainant went to Arsha P.S. and lodged written complain against the accused persons your complainant and the family
