During inspection the accused Sri Amit Das was away from home but his brother Sri Rabindranath Das failed to explain about such unauthorised activity.

Thereafter we have prepared the inspection Report duly signed by the witnesses and disconnected the service line and the illegal loop connection cable and seized the energy meter and loop connection cable under proper seizure list duly signed by the witnesses.

After completion of our inspection and seizure we have left the premises at about 15:45 o'clock.
