In producing herewith one arrested accused person Kesto Majhi (46yrs) S/O- Lt. Sarkar Majhi of vill-Satra, P.S.-Arsha, Dist-Purulia along with following seized articles.

- 12 Bottle of country sprite marks as "Dil Se", 600 ML each bottle & Rs-55/- each bottle (55x12=660/-)
 (One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- 02 Bottle of Kingfisher Beer, 650 ML each bottle & Rs- 125/- each bottle (125x02=250/-)
 (One bottle taken out of the above as sample packed, labeled and scaled with scaling wax)
- One white colour plastic container containing approx 07 ltrs. of ID liquor.
 (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

1. ASI Uttam Das of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 13,08,2024 at about 13.45 hrs. during my anti crime evening mobile duty at Arsha PS area, I received, source information over telephone that the above noted accused was selling ID liquor at Satra village under Arsha P.S. On receiving the source information, I communicated with O/C Arsha PS over telephone. As per direction of O/C, Arsha P.S I along with C/- 848 Priyaranjan Senapati of Arsha P.S and C/- 796 Indrajit Majhi of SAP 7th BN, camp at Arsha P.S work out the information vide Arsha PS GDE No. 583 & C.C. No. 2214 dtd. 13.08.2024. Reaching at Satra village at about 21.15 hrs, we fixed-up in the house of Kesto Majhi (46yrs) S/O- Lt. Sarkar Majhi of vill- Satra, P.S.-Arsha, Dist-Purulia found that selling of Country sprite, Foreign liquor and ld Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehend the above noted accused person namely Kesto Majhi (46yrs) S/O- Lt. Sarkar Majhi of vill-Satra, P.S.-Arsha, Dist-Purulia who was selling foreign liquor, Country sprite and I.D Liquor which he use to sell clandestinely to make his profit. On demand he failed to produce any valid documents in support of selling foreign liquor, Country liquor and I.D Liquor. Accordingly, I seized all those articles after preparing a proper seizure list and put label on all the seized articles from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and one bottle of foreign liquor and country liquor seizure was taken as sample which was also duly labeled and approx 500 ml taken from the white colour plastic container as sample packed with sealing wax with label. It took time from 21.25 hrs. to 21.45 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 21.55 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Kesto Majhi (46 yrs) S/O- Lt. Sarkar Majhi of vill- Satra, P.S.-Arsha,

Dist-Purulia under proper section of law.
