Dear Sir,

I, Goutam Kr. Mandal, S/O- Late Chinta Mani Mandal, Age- 38years, Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Jitendranath Ojha, S/O- Late Niranjana Ojha of Village - Phasko, PS- Arsha, Dist- Purulia has committed theft of electricity U/S 135(i)(b) of electricity act 2003 subsequently amendment act 2007.

On 07.08.2024 at about 12:30 o'clock I, along with Rajesh Kumar, S/O- Late Gulo Ram, Junior Engineer(E).Gr-I, Arsha CCC, Alimuddin Ansary, S/O- Late Miyazan Ansary, Sr. TSH, Arsha CCC and Chandan Mahato, S/O- Late Phani Bhusan Mahato, TSH, Arsha CCC, employees of WBSEDCL went to routine inspection in Phasko Village and entered the premises of Jitendranath Ojha, S/O- Late Niranjana Ojha of Village - Phasko, PS- Arsha, Dist- Purulia and found that Jitendranath Ojha, S/O- Late Niranjana Ojha was enjoying electricity unauthorisedly bypassing the energy meter from incoming side service cable by a loop connection. The bypassing loop connection & service line of Jitendranath Ojha, S/O- Late Niranjana Ojha disconnected on the spot from nearby LTOH Line of WBSEDCL on 07.08.2024. During inspection we found that the service connection is in the name of Jitendranath Ojha having Consumer ID- 202190940, Meter Serial No- BB0085722 and the electrical load he is enjoying as 1.9 KW. The inspection team left the premises of the accused person at about 13.05 o'clock.

Jitendranath Ojha, S/O- Late Niranjana Ojha of Village - Phasko, PS- Arsha, Dist- Purulia has committed an offence U/S 135(i)(b) electricity act 2003(Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
