In producing herewith the 02 (Two) accused person namely (i) Amir Kr. Mahato (24 Yrs), S/O-Mahadeb Mahato of Vill-Datam, PO-Kukru, PS-Tiruldih, Dist-Saraikela Kharswan, (ii) Ganesh Singh Munda (26 Yrs), S/O-Nilkamal Sing Munda of Vill-Shishi, PO-Kukru, PS-Tiruldih, Dist-Saraikela Kharswan along with seized article (1) 04 packet Hawards 5000 Beer (each packet containing 12 pcs sealed bottles of beer & each bottles containing 650 ml), Total-48 pcs Hawards 5000 Beer bottles ,out of which 01(one) Bottle Hawards 5000 Beer containing 650 ml SL No. 1 as sample (2) One black colour Honda CB Shine motor cycle bearing Reg No-JH05CK/5782, Eng No-JC65E-7-2445411, Chasisi No-ME4JC65AAK7279645. The above noted articles has been seized under videography & proper seizure list duly signed by the Police witnesses due to local witnesses did not agree to sign in seizure list.

Today at about 12:05 hrs, received credible source information that some persons are carring some liquor bottles from Kalimati village to Kukru village, Jharkhand by one motor cycle bearing Reg No-JH05CK/5782 for selling without any valid license. Accordingly, I inform the matter to O/C Baghmundi PS and as per order, I ASI Dipak Das along with C/2587 Debasish Gorai & C/2864 Apurba Majhi of Baghmundi PS left for Sirkadih village area, PS-Baghmundi to work out the information, this refers Baghmundi PS GDE No-1976, Dtd: 21.08.2024.

Accordingly, I along with force reached in between Sirkadih to Chora village road near Sirkadih Village at about 13:55 hrs as per information and found that the above noted persons coming from Sirkadih to Chora village riding on a motor cycle bearing Reg No-JH05CK/5782, then I detained them and on search found that they were carrying 04 packets of Hawards 5000 Beer bottles by their motor cycle bearing Reg. No-JH05CK/5782. On demand, they disclosed their identity as noted in above but they failed to produce any valid document from competent authority in respect of above noted Hawards 5000 Beer 48 bottles. Then, in between 14:05 hrs to 14:45 hrs I seized (1) 04 packet Hawards 5000 Beer (each packet containing 12 pcs sealed bottles of beer & each bottles containing 650 ml), Total-48 pcs Hawards 5000 Beer bottles ,out of which 01(one) Bottle Hawards 5000 Beer containing 650 ml SL No. 1 as sample, (2) One black colour Honda CB Shine motor cycle bearing Reg No-JH05CK/5782, Eng No-JC65E-7-2445411, Chasisi No-ME4JC65AAK7279645 from their possession U/S- 67 B.E. Act which were seized under proper seizure list duly signed by the witnesses. One sample bottle was labelled properly in presences of witnesses and accused person. As they have committed the offense as per provision of U/S- 46A (C) B. E Act. So, I arrested the above noted persons in between 14:55 hrs to 15:05 hrs after maintaining all formalities and guidelines regarding arrest.

The arrested accused person namely (i) Amir Kr. Mahato (24 Yrs), S/O-Mahadeb Mahato of Vill-Datam, PO-Kukru, PS-Tiruldih, Dist-Saraikela Kharswan, (ii) Ganesh Sing Munda (26 Yrs), S/O-Nilkamal Sing Munda of Vill-Shishi, PO-Kukru, PS-Tiruldih, Dist-Saraikela Kharswan committed an offence U/S- 46 (A)(c) B.E Act 1909 for unauthorized carrying for selling of illicit liquor (Premium Strong Beer).

Under the fact and circumstances, I therefore pray before you a specific case may kindly be started against the said arrested accused person under proper section of law and arrange its investigation.
