> Sub: Lodging of F.I.R of theft of Electricity against Jabbar Momin ,S/o Lt. Sadimul Momin at his Agricultural Field at Vill.-Hurumda, P.S.-Bagmundih and thereby committed an offence punishable U/S 135(1)(a) of Electricity Act 2003 amended in 2007.

Dear Sir.

This is to inform you that, I Sri Maruti Mahato (45), S/O – Paban Chandra Mahato, A.E. & Station Manager of Bagmundih CCC of WBSEDCL received an information to the effect that Jabbar Momin, S/o Lt. Sadimul Momin residing at Vill.- Hurumda was committing theft of Electricity at his Agricultural Field by means of Direct hooking.

Acting on this information this day 13.08.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit, Sri Anup Mondal, JE GR-I and Sri Biswajit Kumar, TSH of Bagmundih CCC had been to the agricultural field of Jabbar Momin at the above mentioned address. He was present at his Agricultural Field. We contacted him and disclosed our identity to him.

Also search for local people as witnesses during our inspection of the Agricultural Field of the said person but none came forward though some local people gathered there.

During inspection, it was detected that, Jabbar Momin was consuming Electricity illegally by means of Direct hooking at the Agricultural field to commit theft of Electricity. Inspection also revealed that Jabbar Momin was the actual user of the above mentioned illegal connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned illegal service connection and removed the paper insulated cable used for direct hooking. He was shown the illegal connection but being asked he could not render any satisfactory explanation. He was informed about the offence committed by him and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 0.750KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the Agricultural field of Jabbar Momin, it is well established that Jabbar Momin was consuming Electricity illegally in his Agricultural field and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said Agricultural field and illegal hooking arrangement in presence of the accused and witnesses at the spot which he refuses to sign.

The inspection was held between 01:55PM to 02:15PM today after observing all legal formalities.

It is well evident that accused Jabbar Momin, S/o Lt. Sadimul Momin residing at Vill.- Hurumda has committed offence punishable U/S 135(1)(a) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
