Sub:- Complaint against 1) Amal Dutta (40 years) S/O- Ganagasagar Dutta of Vill+ PO- Adardih, PS- Nimdih, Dist- Saraikella Kharswan, Jharkhand & others to start a specific case U/S- 303(2)/ 317(2) BNS.

Respected Sir,

In producing here with arrested accused person 1) Amal Dutta (40 years) S/O- Ganagasagar Dutta of Vill+ PO- Adardih, PS- Nimdih, Dist- Saraikella Kharswan, Jharkhand along with seized 20 (twenty) bags potato (each bags contains approx 45 Kgs), one road Challan of "Maa Kalyaneswari Trading Co.", Tata Yodha vehicle having Reg. No-WB55A/6678 and one blue colour tarpaulin. (details of seized articles are mentioned in attached seizure list), to the effect that today on 07.08.2024, I ASI Subhash ch. Kaibarta along with C/1208 Suresh Ch. Hembram, C/340 Baban Das Goswami, C/3307 Md. Mannan Ansary, C/3331 Nigam Gorai & HG-1556 Ashok Gorai all of Balarampur PS, Purulia was engaged in Naka duty vide Balarampur PS CC No-2272/2024 dt-07.08.2024. In course of Naka Checking duty at about 17:35 hrs., at Dantia Check Post, located at Balarampur Jharkhand interstate border point, I found that one vehicle having Reg. No-WB55A/6678 is coming from Balarampur side towards Jharkhand through NH-32. I along with my force stop the vehicle at Dantia check Post and found that the back side dala of vehicle is cover with blue colour tarpaulin. On asking the driver he refused to disclose the details of articles which he is carrying in his vehicle. After several query the driver disclosed his name as Amal Dutta (40 years) S/O- Ganagasagar Dutta of Vill+ PO- Adardih, PS- Nimdih, Dist- Saraikella Kharswan, Jharkhand and he also disclosed that he is carrying twenty (20) bags potato each bag contains approx 45 Kg. in the back side dala of the vehicle. On demand, he produced one road Challan of Maa Kalyaneswari trading Co, Madhya Bazar Purulia dated- 06.08.2024 and it is found that only ten (10) bag potato is mention in the said Challan and name of the consignee Dinesh Modak of Balarampur Purulia. On interrogation the detain driver Amal Dutta revealed that he has loaded twenty (20) bags potato from Maa Kalyaneswari Trading Co, Madhya Bazar Purulia as per the direction of consignee Dinesh Modak. There is several reason to believe that the driver was carrying extra ten (10) bags of potato (each contains 45 Kg.) illegally as he could not able to produce any valid documents in respect of ten (10) bags of potato & owner of the vehicle having Reg. No- WB55A/6678, supplier of this consignment, Driver of the vehicle Amal Dutta and consignee of the article Dinesh Modak all are involved in this clandestine business.

Accordingly, I seized the article from the possession of accused persons after preparing proper seizure list duly signed by the witnesses. The seizure procedure was done in between 17:35 hrs to 17:55 hrs. Then I arrested accused person namely Amal Dutta (40 years) S/O- Ganagasagar Dutta of Vill+ PO- Adardih, PS- Nimdih, Dist- Saraikella Kharswan, Jharkhand after preparing proper arrest memo as he committed offence U/S -303(2)/ 317(2) BNS after maintaining all the formalities as per NHRC guide line.

The Audio & Videography of entire processes of search and seizure has been done. The videography has been stored in memory card which is enclosed here with.

Under the above circumstances, I therefore pray that a specific case may kindly be started U/S 303(2)/ 317(2) BNS against the arrested accused person namely 1) Amal Dutta (40 years) S/O- Ganagasagar Dutta of Vill+ PO- Adardih, PS- Nimdih, Dist- Saraikella Kharswan, Jharkhand who is the driver of the vehicle bearing Reg. No. WB55A/6678, 2) owner of the vehicle bearing Reg. No. WB55A/6678, 3) Proprietor of Maa Kalyaneswari trading Co, Madhya Bazar Purulia & 4) Dinesh Modak of Balarampur Purulia who is the consignee of potato as per Challan and arrange for its investigation.
