Sub: Lodging F.I.R against Sri Phalari Mahato, S/o. Lt. Daman Mahato for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003. (Amended in 2007).

Sir,

I Sri Sisir Kumar Das, S/O- Banamali Das, D.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sri Phalari Mahato, S/o. Lt. Daman Mahato resides at Vill-Salbani, PS: Balarampur, Dist. Purulia to the effect that received an information, that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information on 27.08.2024 from 02:20 PM to 02:40 PM I, along with Sri Manab Kr. Maji, J.E.(E) Gr-II, Sri Santanu Biswas, O.E of Balarampur CCC and technical persons of M/s. Niharika Electrical (Enlisted Agency of WBSEDCL) inspected the premises of Phalari Mahato and held raid.

During raid and inspection it was detected that accused Phalari Mahato is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 2 Nos. Lamp & 2 Nos. Fan having connected load 320 WATT.

I prepared inspection report in presence of the Accused and assessed the Load as 320 WATT. Details have been mentioned in the Inspection Report on which the son of accused person himself signed.

I directed Sri Sourav Banerjee, Supervisor of M/s. Niharika Electrical (Enlisted Agency of WBSEDCL) to disconnect the hooking line/ arrangement from our LTOH line. Accordingly they disconnected the aforesaid hooking line/arrangement from LTOH Line.

I prepared seizure list in presence of the representative of accused person & witnesses, details of seizure have been mentioned in the seizure list and the accused person signed on it. The Local people gathered there witnessed the incident and the son of accused person agreed to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the abovementioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
