Sir

In producing here with 02 (two) arrested accused persons namely 1) Satish Ch. Mahato (45 yrs approx) S/O- Lt. Bhriguram Mahato & 2) Rabi Mahato S/O- Satish Ch. Mahato both of Vill- Arahasa, P.S.- Balarampur, Dist- Purulia along with following seized articles -

- 1) 01 (one) white colour jarican containing approx 09 (nine) Ltrs. ID liquor (CHOLAI), 500 ml taken from mother container in a plastic bottle as sample.
- 2) 07 (seven) pieces NISHADAL Approx 100 gms,
- 3) 02 (two) pieces steel glass
- 4) Sell proceed of Rs. 155/-

I ASI Manas Kr. Pan of Balarampur P.S. do here by lodge a complaint against accused persons namely 1) Satish Ch. Mahato (45 yrs approx) S/O- Lt. Bhriguram Mahato & 2) Rabi Mahato S/O- Satish Ch. Mahato both of Vill- Arahasa, P.S.- Balarampur, Dist- Purulia to the effect that today (27.08.2024) at about 20:05 hrs. in course of mobile duty I received a telephonic information from a reliable source that the accused persons 1) Satish Ch. Mahato (45 yrs approx) S/O- Lt. Bhriguram Mahato & 2) Rabi Mahato S/O- Satish Ch. Mahato both of Vill- Arahasa, P.S.- Balarampur, Dist- Purulia stocked ID liquor (Cholai) illegally and selling the same to hike price for his personal gain, then I informed the matter to O/C Balarampur PS and as per order of O/C Balarampur PS myself along with force rushed to the spot to conduct raid by Govt. vehicle. At about 20:35 hrs myself along with force reached at Balarampur Bypass mohr beside NH-32 and held raid in a abandent house and found that the accused persons were mixing the ID liquor (Cholai), contained in a plastic container, with some intoxicated substance (like white powder bar) having acrid smell which is likely to cause disability or death to human being, in a abandent house near Balarampur Bypass mohr beside NH-32 and seeing the police party some person fled away but police party anyhow managed to apprehend above noted 02 (two) accused persons and detained them. I asked them about the white powder bar like substance and accordingly, detained accused person recognized it as "NISHADAL" (approx 100 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. Hence I seized the above mentioned articles after preparing proper seizure list duly signed by accd. persons as well as witnesses and arrested the above mentioned accused persons maintaining all guidelines of the Apex Court of India & NHRC regarding arrest.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accused persons namely 1) Satish Ch. Mahato (45 yrs approx) S/O- Lt. Bhriguram Mahato & 2) Rabi Mahato S/O- Satish Ch. Mahato both of Vill- Arahasa, P.S.- Balarampur, Dist- Purulia and arrange for its investigation.
