Sub: Prayer for lodging FIR as per law against the Driver & Owner of the stone loaded dumper having registration no- WB 49 3302 loaded 24 MT (Ton) approx. stone chips

Sir,

In producing here with one arrested accused person namely Prasanta Karmakar(30y),S/O-Kamal Karmakar of Vill-Talpokuria ,PO- Charakpahari, PS-Belpahari, Dist-Jhargram alongwith seized one stone loaded dumper saving registration no- WB 49 3302 loaded 24 MT (Ton) approx. stone chips.

I beg to state that on 04.08.2024 myself ASI Dhaneswar Mahato along with C/2485 Tirthankar Samanta and C/536 Astik Bauri all are of Bandwan PS were performing evening mobile duty with Govt. vehicle. Vide Bandwan PS GDE No- 221 dated 04.08.24 and cc no-2704 dated 04.08.24 when we were approaching towards Bandwan PS from Bandwan Barabazar bypass more at about 19.30 hrs found that the one stone loaded hyba or dumper standing beside the pitch road at a vacant place at near Sarada filling Station . Seeing the police party the driver of the vehicle tried to escape from the place hiding himself . How ever we managed to apprehend the driver . After interrogation the driver of the said offending vehicle disclosed his identity as noted above. I asked him to produce any valid documents or legal challan for any legal authorisation to excavate the stone which is loaded in dumper and whether he has any permission for transportation of the stone but he failed to produce any valid documents.

I communicated the entire matter to O/C, Bandwan PS over phone and Seized the Dumper having registration no- WB 49 3302 loaded with 24 MT (Ton) approx. stone chips under proper seizure list duly signed by witness. The seizure was done in between 19.35 hrs and 19.45 hrs under videography by SI Suvajit Nandi of Bandwan PS as per provision of BNSS. After that at 19.55 hrs I arrested the accused driver as noted above after maintaining all formalities regarding arrest. I also informed him regarding the grounds of arrest and informed concerned Police station(Belpahari PS, Dist-Jhargram) to serve the information to his relatives.

During interrogation of the driver namely Prasanta Karmakar(30y),S/O-Kamal Karmakar of Vill-Talpokuria ,PO- Charakpahari, PS-Belpahari, Dist-Jhargram it became crystal clear that he and the owner of the said vehicle

namely Sujit Garai, S/O-Sudhakar Garai of Vill-Hijla, PO-Bhelaidiha, PS-Belpahari, Dist-Jhargram collected and loaded the stone either by theft or some other illegal means with intent to make monetary profit by unlawful collection of stone through illegal means by unauthorized collection and transportation of mines & minerals and it has been a regular practice for them for last few months. By this way they violated the regulation of procurement of mine & minerals. As such there is every reason to believe that the driver and owner of the said viva dumper were transporting the stone illegally without any valid document.

Under the above facts and circumstances, I pray before you to kindly take necessary legal action against the arrested driver namely Prasanta Karmakar(30y),S/O-Kamal Karmakar of Vill-Talpururia ,PO- Charakpahari, PS-Belpahari, Dist-Jhargram & owner of the vehicle bearing Registration No-WB 49 3302 namely Sujit Garai, S/O-Sudhakar Garai of Vill-Hijla, PO-Bhelaidiha, PS-Belpahari, Dist-Jhargram and initiate an FIR and also request for arranging its Investigation.
