I do hereby lodge complaint empowered by enabling The Indian Electricity Act - 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Rameswar Hembram, S/O - Jhamglu Hembram, Vill- Henselghutu, PO - Kuchia, PS - Bundwan, Dist - Purulia has committed theft of electricity U/S 135/1/b of The Electricity Act.

On 08/08/2024 about 13:15 Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSECL, along with, Subhankar Majumdar, Sr. TSH, Bundwan CCC, WBSECL and Raghunath Saren, Office Executive, Bundwan CCC, WBSECL visited the premises of Rameswar Hembram, S/O - Jhamglu Hembram, Vill- Henselghutu, PO - Kuchia, PS - Bundwan, Dist - Purulia and inspect his premises. During inspection it was found that he was using electricity dishonestly by bypassing the meter and connecting the incoming power with outgoing wire before entering the meter.

From the above arrangement he was using the following electrical equipment's:

- 1) FAN - 1 Nos, 2) Bulb - 4 Nos,

Out of which I seized the following:

- 1) PVC Black color service cable of approx. 12 ft.

Seizure list was prepared at the site and accused person has signed.

The inspection team left the premises at 13:55Hrs on 08/08/2024.

The accused person has committed an offence U/S 135/1/b of The Electricity Act - 2003 & subsequently Electricity (Amendment) Act - 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
