Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007, to the effect that MILAN SAHISH S/O CHEPU SAHIS, VILL – PANJANBERA, Dist- Purulia was enjoying electricity illegally by connecting a wire between incoming terminal of the energy meter and the main switch of the consumer directly by by-passing the Single Phase Energy Meter (SI No- RBRT04781). Thereby, He has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

At About 12:05 P.M., entered into the premises of MILAN SAHISH S/O CHEPU SAHIS of village – PANJANBERA Dist- Purulia and inspected his premises .

while doing inspection at the premises of MILAN SAHISH S/O CHEPU SAHIS of village: PANJANBERA in presence of MILAN SAHISH , we found that the accused one was using electricity by means of by passing the meter consumption having connected load 1.53 KW.

Seizure list was prepared at site which he refused to sign. After process of inspection and seizure list we left the premises at about 12:25 P.M.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.
