Sub: - Complaint for lodging FIR.

Sir,

I, SI Mukul Karmakar of Barabazar PS do hereby submit complaint against the arrested accused driver namely Manoj Kr. Dutta (22 yrs) S/o Bhajan Kr. Dutta of Vill-Jawrah, PS-Boro, Dist-Purulia & others. To the effect that today on 19.08.2024 during mobile duty vide Barabazar PS GDE No- 1100 dtd-19.08.2024 & C.C No-3929 dtd. 19.08.24 on Barabazar-Manbazar road at about 08.15 hrs I, received a telephonic information from a reliable person that one vehicle loaded with cow/calf was coming from Manbazar side tied with rope in a cruel manner without any valid documents or proper permission from concern authority. The matter was intimated to I/C Barabazar PS and as per his kind instruction I along with Sl Mantu Karar and accompanied force C/-730 Tapas Mandal, C/-1246 Shaktipada Mahato of Barabazar PS rushed to Sindri Sadhurpogar on SH-4 at about 08.40 hrs. and detained the driver of the said vehicle having Reg. No WB55A-1512 & 01 person fled away from the clutch of us. Then, I found that the vehicle bearing Reg. No. WB 55A/1512 loaded with 05 nos of calf in the vehicles tied with rope in a cruel manner. I asked for valid documents to the driver but he did not produce any valid documents. So, I arrested the accused driver namely Manoj Kr. Dutta (22 yrs) S/o Bhajan Kr. Dutta of Vill-Jawrah, PS-Boro, Dist-Purulia. There is every reason to believe that the accd. driver along with 01 other have procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. Moreover, they were carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space.

Accused driver along with 01 other treated the cattle in such a manner so as subject those to tinnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently. Hence, I seized Total 05 (Five) Cattle (Calf) [details are mentioned in the attached seizure list] and the vehicle noted above seized from the P.O under proper seizure list and took signature of arrested accused driver and Police witnesses and as the miscreants committed offence U/S- 303 (2)/317(2) B.N.S and r/w Section- 11(1)(d)(e)(f) The Prevention of cruelty to Animal Act 1960. After that I brought the arrested accused driver and the calf loaded seized vehicle into Barabazar PS and as per order of I/C Barabazar PS, the said 05 nos of cattle/calf has been made Zimma to the Anup Kr. Agarwala S/o-Kishorilal Agarwala of At+PS-Balarampur, Dist-Purulia for proper care & raring of those cattle/calf with a direction to produce the said animals before Hon'ble Court when as required or ordered as the livestock could not be kept in PS Malkhana.

I, therefore pray that an specific case may kindly be started against the accused driver Manoj Kr. Dutta (22 yrs) S/o Bhajan Kr. Dutta of Vill-Jawrah, PS-Boro, Dist-Purulia & owner of vehicle No- WB 55A/1512) and others U/S- 303 (2)/317(2) B.N.S and r/w Section- 11(1)(d)(e)(f) The Prevention of cruelty to Animal Act 1960 and arrange for its investigation.
