Sub: Complaint against Sistidhar Mahato (52 yrs) S/o Lt. Kripa Mahato of Vill-Bodhadih, PS-Barabazar, Dist-Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Sistidhar Mahato (52 yrs) S/o Lt. Kripa Mahato of Vill-Bodhadih, PS-Barabazar, Dist-Purulia along with Memo of arrest, Seizure List, Check List and seized article i.e- 01 (One) white colour Plastic Jarikane containing approx 10 (Ten) liters of I.D liquors (Cholai) from which 500 ML ID Liquor (Cholai) kept as sample from mother contrabands.

I, ASI Rabindranath Mandal of Barabazar PS do here by lodge this complaint against one Sistidhar Mahato (52 yrs) S/o Lt. Kripa Mahato of Vill-Bodhadih, PS-Barabazar, Dist-Purulia to the effect that today on 22.08.2024 myself along with force (i) C/730 Tapas Mandal & (ii) C/838 Rakhal Ch. Mahato were left for evening mobile duty vide Barabazar PS C.C No- 3979/24 Dtd. 22.08.2024. During mobile duty at about 19:15 hrs I received information that 01 (One) person was keeping and selling I.D liquor (Cholai) at Bodhadih village under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with force had been to the spot to work out the information.

At about 19:45 hrs myself along with force held raid beside the Bodhadih village morh and found that one person was keeping & selling I.D liquor (Cholai). When we reached in front of said place, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking one white colour Plastic Jarikane containing approx 10 (Ten) liters of LD liquors (Cholai) and selling beside the Bodhadih village morh. On demand, he failed to produce any valid documents/ License in respect of keeping & selling of I.D liquors (Cholai). On being asked he disclosed his identity & confessed his guilt and stated that he selling the ID liquors (Cholai) with intent to sell to make own profit. He also admitted that he had no license or any authorization to keeping and selling of ID Liquor. Accordingly, I seized the above noted article under proper seizure list duly signed by the witnesses and label it. 500 ML of LD liquor (Cholai) taken as sample from the mother contrabands. The seizure and label was done in between 20:05 hrs to 20:15 hrs. I asked the local people as witnesses but none turned up.

Thereafter, I secured arrest of the above noted accused person after preparing Memo of Arrest, inspecton memo, issuing checklist and after observing all other formalities regarding arrest as per B.N.S.S and NHRC guide line. Informed him and his relatives regarding the ground of arrest. Arrest was made on today i.e. 22.08.2024 at 20:20 hrs.

Under the above fact & circumstances I, therefore, pray before you that as per law a specific case may kindly be registered against Sistidhar Mahato (52 yrs) S/o Lt. Kripa Mahato of Vill-Bodhadih, PS-Barabazar, Dist-Purulia and also arranging for its investigation.
