I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that AJIT SUTRADHAR, S/O LT LALIT SUTRADHAR VILL – SINDRI, Dist- Purulia was enjoying electricity illegally by connecting a wire between incoming terminal of the energy meter and the main switch of the consumer directly by by-passing the Single Phase Energy Meter (Sl No- 55369294) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

while doing inspection at the premises of AJIT SUTRADHAR, S/O LT LALIT SUTRADHAR of village: SINDRI in presence of AJIT SUTRADHAR, we found that the accused one was using electricity by means of by passing the meter consumption having connected load 1.00 KW.
