I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007, to the effect that AJIT SUTRADHAR, S/O LT LALIT SUTRADHAR VILL - SINDRI, Dist- Purulia was enjoying electricity illegally by connecting a wire between incoming terminal of the energy meter and the main switch of the consumer directly by by-passing the Single Phase Energy Meter (SI No- 55369294) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

while doing inspection at the premises of AJIT SUTRADHAR, S/O LT LAUT SUTRADHAR of village: SINDRI in presence of AJIT SUTRADHAR, we found that the accused one was using electricity by means of by passing the meter consumption having connected load 1.00 KW.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.
